Except as specifically set forth above, Coolcentric Products have a 1-Year Parts Only Limited Warranty.

This Warranty is subject to certain exceptions as noted below.

Warranty

Coolcentric warrants that the Products will operate in accordance with the Applicable Specifications for such Products and will be free from defects in materials and workmanship, provided that the Products are applied, installed and maintained in accordance with Coolcentric's Documentation.
